### **A Chance to Advocate ANF Wilderness at Second Round of Forest Plan Revision Workshops in August**

The Allegheny National Forest (ANF) will host a second round of workshops for Forest Plan revision on August 14th, 16th, and 18th. Like the initial round of workshops in May, these workshops are a way for people to become involved in protecting new ANF wilderness as part of the process for Forest Plan revision. The dates and locations are:

August 14th, Quality Inn and Suites, east of Erie, junction of Interstate 90 and PA Route 97, 2 p.m. until 9 p.m., with breaks.

August 16th, Holiday Inn, off U.S. Route 6, west of Warren, 9 a.m. to 4 p.m., with breaks.

August 18th, Ramada Inn, off U.S. Route 322, east of State College, 2 p.m. until 9 p.m., with breaks.

These workshops seek to accomplish several objectives:

--Facilitators will present to the public what was learned at the first two workshops in DuBois and Bradford on May 2nd and 3rd;

--ANF planning staff will talk about how public comments are tracked and processed during plan revision, and they will ask for suggestions how to improve this work; and

--The workshops will also provide another opportunity for the public to give comments in a collaborative learning setting

regarding their concerns and issues about management of the ANF.

Earlier, as part of the DuBois and Bradford workshops, the public presented suggestions to improve the public involvement process for Forest Plan Revision. According to the ANF, suggestions included publishing notice of meetings further in advance and via more methods. Participants suggested more meetings further from the ANF to draw more participants, particularly forest users from urban areas. The Erie and State College locations provide ready access to the largest concentrations of ANF users from urban areas. At the same time, many other people suggested keeping meetings near the ANF, and the Warren location will continue workshops near the Forest.

The public found the use of non-Forest Service facilitators and the collaborative learning mode of public input, with small group work, to be comfortable and productive. The August workshops follow the pattern of the DuBois and Bradford meetings, taking advantage of outside facilitators and a collaborative learning style of interaction. **A Forest Partnership: Conservation group teams with USFS on trail work**

A local conservationist group has teamed up with the U.S. Forest Service to maintain a hiking trail in a wilderness area of the Allegheny National Forest.

The Friends of Allegheny Wilderness (FAW) have adopted the Hickory Creek Wilderness Trail, an 11-mile loop near Heart's Content. FAW have agreed to provide maintenance for the trail, coordinating with U.S. Forest Wilderness Ranger Eric Flood, who is based in Bradford.

"It's a way of maintaining wilderness resources," FAW director Kirk Johnson says. "Our original priority at this point is significantly increasing wilderness. But it's also important that we appreciate and maintain current wilderness areas."

FAW officially adopted the Hickory Creek trail last fall. Since then, FAW has participated in three maintenance events this year, including tree planting and blow-down cleanup.

Most recently, FAW and Flood, along with members of the Student Conservation Association, spent a weekend in mid-June repairing a marshy area of the trail near Coon Run.

"We tried to create some drainage out of muddy areas and harden it with rock," Flood says. "We tried to make it as natural looking as we could."

In May, FAW and Flood planted trees to reclaim an old logging road near the Heart's Content campground that people were mistaking for part of the trail.

"We naturalized that road as much as we can," Flood says. "It's the remnant of an old wood road. People were actually maintaining it without a permit. It was causing conflicting interest with the wilderness values and confusions with the trail. It actually does cross the trail."

According to Flood, FAW donated trees for planting in the area of the road.

Also in May, the volunteers cleared blown down trees and limbs from sections of the trail using primitive hand tools.

"It's a 'leave no trace,' area," Flood says. "We try to keep our party size to a minimum. And we use the minimum tools. What that means is whatever I need to accomplish, I use the most minimum tool it takes to accomplish it. Often that means me, on foot, with an ax."

In addition, the volunteers use shovels and mattox to perform repair work on the trail. Chain saws are prohibited.

“Under the Wilderness Act,” Flood says, “all motorized equipment is prohibited. That applies to me, as well.”

According to Flood, he would like to get in one more cleanup event this year. But there's still work to be done on drainage near Coon Run.

### **Contact Your Legislators For Allegheny National Forest Wilderness!**

The Forest Service has the ability to recommend new wilderness designations in the Allegheny National Forest as part of its Forest Plan revision. However, only Congress can make the designations final by passing a law. To get additional areas of the ANF permanently protected as wilderness, it will require the support of the Commonwealth's federal legislators.

In particular, if you live in the Congressional District of Representatives John Peterson (5<sup>th</sup> district) or Phil English (3<sup>rd</sup>

district), please take the time to contact them and thank them for their attention to this issue to date. Encourage them to work toward drafting significant new wilderness legislation for the ANF in the near future.
