From the Director

Well, it has been a while since I have opened our newsletter with a *From the Director* message. However, a lot has been happening with the Friends of Allegheny Wilderness campaign this year, and it seems like a good time to touch base with all of our old – and welcome new – friends.

Due largely to the enterprising work of our new grassroots organizer John Bartlett, who came on board in March, our membership numbers have grown substantially in recent months. Also, organizational endorsements of the *Citizens' Wilderness Proposal for Pennsylvania's Allegheny National Forest* have continued to roll in (we are now up to 27 local, regional, and national organizations!). Renowned wilderness historian Doug Scott has visited our region twice this year to promote the *Citizens' Wilderness Proposal* and his excellent book, *The Enduring Wilderness*, and many other exciting developments are underway. Momentum is clearly growing on a number of different levels!

The bad news is, the Forest Service only recommended two wilderness areas totaling a little under 13,000 acres in their revised Forest Plan, which was published in March. This is far short of the eight areas and 54,460 acres outlined in the *Citizens' Wilderness Proposal*. Also, oil and gas development on the Allegheny continues to expand. Due to overarching geopolitical conditions, a boom period for the industry is underway – not just in Pennsylvania or nationwide, but worldwide. This has translated into

hundreds of new wells being drilled locally in the Allegheny National Forest in recent years, with hundreds – if not thousands – to come. Some of this new development is even beginning to affect the most remote areas of the forest, such as the areas we have proposed for wilderness protection.

Fisher (*Martes pennanti*): Predator and member of the weasel family (*Mustelidae*). The fisher has a narrow body, bushy tail, tapered muzzle, and low, rounded ears. Adults are usually 31 to 47 inches long. Once abundant in NW Pennsylvania, fishers were unable to cope with the unregulated trapping and widespread clearcutting of the 1800s, and so were extirpated. Reintroduction began in 1994, and since then about 190 fishers have been reintroduced in PA.
